.Responsibility

Responsibility Jaunay Lake campground is not liable for any theft, loss or damage of any kind during or after a stay in the event of failure or decommissioning of technical equipment.

Children must be supervised by their parents.

The camper must have liability insurance.

Reservation

It is effective upon receipt of the completed (rental agreement) and deposit (30% of the total rental amount + 10 € processing fee + insurance cancellation and interruption of stay (optional).

No fees for all the weekends formulas and all the off season holidays stayings..

Any choice made by telephone must be confirmed

- In writing within 72 hours with a deposit and a stamped envelope for confirmation

- By credit card payment of the deposit you will immediately block booking.

The balance of the rental must be paid 30 days before arrival at the campsite

Bail

You will be asked for a deposit of 150 euros for rent and 50 Euros for cleaning returned within 8 days if no damage and clean condition. The bonds will be requested upon arrival.

Pets

They are accepted provided they are tattooed, vaccinated (with supporting documents) presented on the day of arrival and only be always with the leash and should not be left alone in the rental or outside in the absence of their owner.

Pool

Swimming trunks are mandatory for the bathing, shorts are not allowed for swimming.

Children are under the responsibility of their parents.

Barbecues

Barbecues on lively fire are forbidden (gas barbecues can be leased).

Cancellation

Everything started stay is due in full.

No reduction will be granted in the case of delayed arrival or early departure.

In the case of cancellation, no refund of the deposit will be refunded.

Interruption of stay cancellation insurance (recommended)

4% of the accommodation cost inclusive of all taxes (excluding booking fees and taxes).

The amount is payable in full and only when booking. It pays the penalty in case of cancellation or change of residence for a pattern guaranteed.

Rental Terms and Conditions

Everybody on the site has to respect the internal regulation (available at the reception).

Non-compliance of the rules and general conditions of the campsite after a warning will result in expulsion without refund of the stay.

We remind you that smoking is not allowed in mobile homes and chalets.

All bookings are personal and it is forbidden to sublet or assign the mobile home to someone.

Photographs may be taken during your stay, if you do not want to be photographed, you have to notify it in writing and hand delivered to the campsite manager upon arrival.
